1. ACT Weeds of National Significance (WONS) Grants Program

The ACT Natural Resource Management (NRM) Council, with support from the Australian Government's Caring for our Country (CFOC) program, is making \$330,000 available for targeted control of Weeds of National Significance (WONS) within the ACT.

Funding is available to support community groups and rural landholders in managing WONS in the ACT through strategic and well planned on-ground actions. The principle WONS that funds can be used to control are: Blackberry (*Rubus fruticosus aggregate*); Chilean Needle Grass (*Nassella neesiana*); and Serrated Tussock (*Nassella trichotoma*).

Grants of between \$5,000 and \$100,000 will be offered, with proponents being expected to match the funds sought 1:1 through cash and/or in-kind contributions.

2. Biodiversity Fund opens

The Minister for Sustainability, Environment, Water, Population and Communities, Mr Tony Burke, officially launched the first grant application round of the Biodiversity Fund. On Friday 9th December. The Biodiversity Fund is a key element of the Australian Government's Clean Energy Future Land Sector Package and supports land managers to store carbon, enhance biodiversity and build resilience across the Australian landscape.

Applications close 5pm AEDT Tuesday 31 January 2012.

The Biodiversity Fund provides support to land managers to establish new biodiverse carbon stores or better manage existing stores in high conservation areas. So, if you have a good idea for a project that involves activities which restore, manage or better protect biodiversity on public or private land, you are encouraged to submit a Biodiversity Fund application.

3. Don't be a Drifter Herbicide spraying workshops

Southern ACT Catchment Group is organizing another 'Don't Be A Drifter' herbicide use training course at Westwood Farm near Kambah and run by Craig Day from 'Spray Safe and Save'. Craig adapts the course content to suit the requirements of the participants. Craig is an excellent presenter with a truly in-depth knowledge of all aspects of herbicide use and the legislation surrounding it. The practical sessions clearly demonstrate the learning gained from the theory sessions. All people using herbicides at any level could gain a greater understanding of all aspects of herbicide use by undertaking this course, whether they are seeking accreditation, reaccreditation (AQF3/4) or simply a better knowledge base to work from regarding drift reduction, nozzle selection, equipment selection and calibration and OH&S to name a just few aspects. All costs are covered through funding to the catchment group from ActewAGL and the ACT NRM Council. The course is on the weekend 18-19 February and is open to urban, landcarers / Park Carers and landholders and managers across the ACT or in the Googong or Upper Murrumbidgee catchments (within 50 km south of the ACT border). 7. Local Group wins national award

SACTCG member MOTH (Minders of Tuggeranong Homestead) has won a prestigious award from the Savewater Alliance, a not-for-profit organisation that is considered to be Australia's leading advocate for water efficiency and sustainable practice. At their annual awards in Melbourne on 11 November, MOTH received the Community award for its achievements in water conservation at Tuggeranong Homestead. With funds from a Commonwealth grant, MOTH arranged for the replacement of seven unusable water tanks and the installation of new ones which provide non-potable water for the use of the homestead and gardens. This project has led to an estimated 60% savings in the use of potable water on the property.

8. Centenary Trail in Canberra

The idea for a Centenary Trail in Canberra arose from community submissions received in 2009 as part of the Canberra 100 call for Centenary projects. The Trail is intended to be a showcase of Canberra, taking users on a seamless journey between urban and rural environs and incorporating the ACT's iconic sites and hidden treasures. A Canberra Centenary Trail Feasibility Report was prepared for Parks and Conservation Service, which assesses the feasibility of the proposal in terms of estimated costs and predicted benefits.

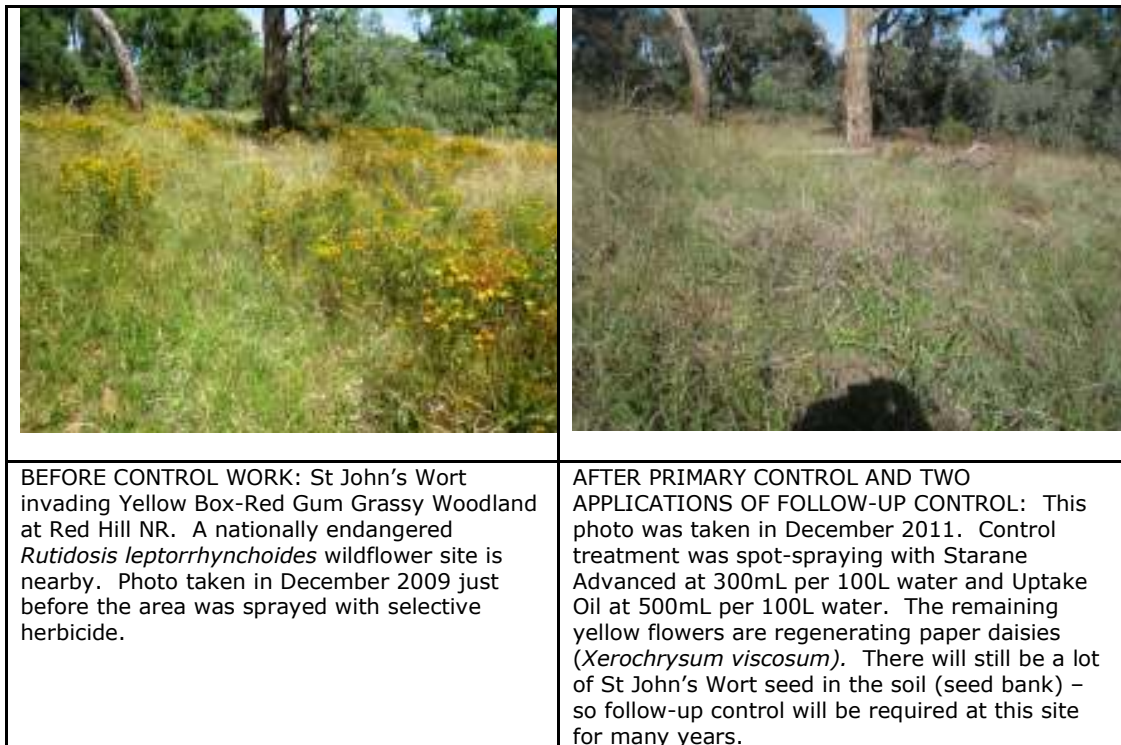

Additionally Coleman Ridge recently had major earthworks undertaken around the base of the Ridge to produce a large drain to carry large amounts of water away from the houses. A member of the Coleman Ridge Parkcare Group, has noticed Bathurst Burr may have been imported with the soil used in the works.

On a brighter note Steve Taylor has provided this information on ST John's Wort:

- *We are experiencing a bumper year for St John's Wort (a 'High' risk weed with new infestations appearing seemingly everywhere).*
- *Our management strategy for this weed is to 'Protect priority sites'. The two photos below show what can be achieved if you stay focused on doing frequent follow-up control at your 'priority sites'.*
- *Lesson here: don't go chasing the new infestations till you have completed control work at all your follow-up sites.*



12.Census of ACT Flora - 15 Dec 2011

Environmental Knowledge & Awareness Seminar:

This Census lists the scientific names of the native and naturalised vascular plants (Pinophyta and Magnoliophyta), hornworts (Anthocerothyta) and liverworts (Marchantiophyta) known to occur in the Australian Capital Territory. All records are based on herbarium specimens housed in the Australian National Herbarium in Canberra. The Census is a 'work in progress' and now includes data on some previously unrepresented flora groups including mosses, lichens, algae, fungi and slime moulds.

15.Free Frogs

Around 200 northern corroboree frogs have been released into the wild for the very first time after eight years of breeding in captivity as part of a program to save the endangered species, Minister for the Environment and Sustainable Development, Simon Corbell, announced on the 25 November.

'In 2003, the ACT Government established a captive colony of the endangered northern corroboree frog at Tidbinbilla Nature Reserve in response to a continuing decline of wild populations,' Mr Corbell said.

'This release is the culmination of eight years of raising and breeding northern corroboree frogs by government ecologists and Tidbinbilla wildlife officers and represents a significant milestone for the Government in protecting this endangered species.'

16.NRM website

A new Australian Government natural resource management (NRM) website has been launched at www.nrm.gov.au.

The website provides easier access to information on funding opportunities and program outcomes relating to *Caring for our Country*, the Australian Government's NRM initiative, which is administered by Australian Government Land and Coasts.

The site includes a new design, a more user-centred structure and a strong focus on work achieved through *Caring for our Country* through a dedicated projects area.

It also features a substantial archive of reference material from Australian Government funded NRM projects. The reference collection is linked to commonly used search engines, including academic ones, and is expected to have more material added over time.

17.Statement of common purpose between Landcare and Regional NRM

The first draft of the statement of common purpose between Landcare and Regional NRM Organisations is currently being circulated to Landcare networks/members for comment. Deadline for comments 13th January 2012. This Statement of Common Purpose is an agreement between the National Landcare Network and the National NRM Regions' Working Group.

The National Landcare Network is the advocacy and representative body for Landcare at the national level. It consists of the representatives from peak bodies for Landcare in each State and Territory.

The National NRM Regions' Working Group is the representative body of the Chairs of Australia's 56 regional Natural Resource Management organisations. Its members are the representatives from the State and Territory groups of the Chairs.

This initiative is supported by the Australian Landcare Council, Landcare Australia Limited and the National Landcare Facilitator.
