### **Lower Molonglo Corridor – Walk and Talk 16 May**

It's not often that we get an opportunity to learn about a little known part of the Molonglo Valley – the Lower Molonglo River Corridor, the section of the Molonglo River just above where it joins the Murrumbidgee. It is precious because it contains rare flora and fauna, and significant geological features; it is also rare for raptors to nest in an area so close to a large city. And yet an entirely new urban development is planned upstream. Join a Parks Conservation and Lands Ranger for a walk along part of the lower Molonglo River Corridor. Learn about current river management issues along this section of the Molonglo, including weeds, native vegetation, threatened species and water quality. ## **Namadgi Feral Pig Control**

From the morning of Thursday the 6th of May until the end of Friday the 21st May 2010, Namadgi National Park will be conducting its annual Feral Pig - Poison Baiting Program. Depending on animal activity, the program may be extended until Friday to 28th May in selected areas of the park.

This program has been run every year for the last 15 years and in the past has been highly successful in reducing pig numbers and the ecological damage they cause within the park.

The continued success of the program depends largely on areas of operation being relatively undisturbed so that pigs in the area feel comfortable enough to approach bait stations and take the offered poisoned baits.

In response to this, a notification of closure was released earlier this week giving notice that without consultation with Namadgi National Park, vehicle access to all non public roads and fire trails within the park would be restricted to essential services and park staff for the duration of the program.

The notification also advises people of the presence of toxic baits within the park and the danger to humans and domestic animals of these baits. All baits will be removed at the end of operations.

Areas of operation will be clearly marked at each end with conspicuous red on white "1080 Poison" signs. The green, cylindrical shaped baits will be placed under red plastic tubs anchored to the ground in such a way that will prevent animals other than pigs accessing the baits. The program will have minimal negative impact on visitor access within the park and all fire and management trails will remain open to bushwalkers and recreation groups.

The Murrumbidgee Catchment Management Authority (MCMA) has announced the opening of 'The Bidgee from Behind the Lens' photographic competition to celebrate the Murrumbidgee catchment's natural assets. The Murrumbidgee catchment has one of the most diverse climates in NSW – from alpine areas of Kosciuszko National Park, through to the rich grazing belts of the South-West Slopes and grasslands of the semi-arid western Riverina. The MCMA would like to capture the diversity, beauty and sustainable management of the Murrumbidgee catchment and invites entries that may include, but are not limited to, images of wildlife, flora, landscapes, wetlands and rivers, sustainable farming practices and communities living in and caring for the catchment.

There are four categories – Primary Student; Secondary Student; Open Amateur; and Open Professional. Photographs can be historic or recent, black and white or colour – but they must be from the Murrumbidgee catchment. Only digital entries will be accepted.

Cash prizes of \$250 will be offered for first place and \$100 for runner up in each category.

## Volunteers have an eye for platypus

ACT Waterwatch is looking for volunteers to join the Platypus Count effort through-out Canberra and the region. Organised by ACT Waterwatch and the Australian Platypus Conservancy, the work helps researchers keep tabs on how platypus and water-rats are faring in the ACT.

*“With the recent deaths of two platypus in illegal nets, and animals being discovered in Queanbeyan entangled in rubbish, monitoring populations is essential. Aquatic animals are quite vulnerable as climate change, drought and human activity chew away at their fragile habitat. The more we know about them, the better we can protect them and the other animals that share their habitat”*  
Tanya Rucosky Noakes, ACT Waterwatch Facilitator said.

“The *Platypus Count* project is a great way to volunteer for your community and can easily be combined with your routine walk, jog or cycle ride, so the time commitment is not great,” said Ms Rucosky Noakes.

ACT Waterwatch will be hosting information sessions (details below) about the platypus program at the Aboriginal and Torres Strait Islander Cultural Centre and at the Michelago Community Hall. Dr Melody Serena from the Australian Platypus Conservancy will give an illustrated talk about the platypus’s unusual biological features and describe the *ACT Region Platypus Count* program for those who may wish to become involved.

Spotting a platypus in the wild remains a long-cherished ambition of many people. Thus, Dr. Serena will lead a dawn platypus walk along the Queanbeyan River (a local platypus hot spot).

Local platypus monitor and Queanbeyan resident, Corrie van Seville-Ellis, says observing the world’s strangest animal in its natural habitat has become almost a matter of routine. Since joining the *ACT Platypus Count* monitoring project last year, Corrie has made numerous sightings of the supposedly-shy monotreme in the Queanbeyan River. “I saw the most adorable baby only a few days ago!” said Corrie. “I usually see two to three every time I go out looking for them, now”

With her local knowledge, Corrie will join the dawn hike and demonstrate how spending just a few minutes scanning the water at a number of spots as she walks has rewarded her with lots of great views of platypus and Australian water-rats, another fascinating native species.
